Off-Licence

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **The Wild Ones Limited** (the licensee) is authorised to sell alcohol on the premises situated at **Unit 4-6 Northpoint Street**, **Plimmerton**, **Porirua** and known as **The Wild Ones**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

ENDORSEMENT

Section 40 of the Act applies to this licence; and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- (a) No alcohol is to be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
- (b) Alcohol may only be sold or supplied and delivered on the following days and during the following hours:

Sale: Any day at any time

Delivery: Monday to Sunday between 7 am and 10 pm.

- (c) There must be a certified manager, temporary or acting manager appointed to the business by the licensee.
- (d) The licensee must take reasonable steps to verify that the buyer (and if applicable, the receiver) is not under the purchase age in compliance with reg 14 of the Sale and Supply of Alcohol Regulations 2013.
- (e) A copy of the licence must be displayed:
 - i. on every receipt issued for alcohol sold;
 - ii. in every catalogue, if alcohol is sold by remote sale using catalogues; and
 - iii. on the internet site, if alcohol is sold by remote sale using an internet site.
- (f) Alcohol that is to be sold as part of a gift basket/hamper must contain other non-alcoholic products.
- (g) The outside of the delivery package must contain the following warning for courier:
 - i. do not leave at destination without proof of delivery;
 - ii. do not leave with persons under 18 years of age. If the receiver appears to be under the age of 25 years check valid identification such as current passport, a New Zealand driver's licence, a valid Kiwi Access or HENZ 18+ card;
 - iii. do not leave with intoxicated persons; and
 - iv. contains alcoholic product(s).

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) either-
 - (i) until the close of the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either-
 - (i) until the close of the period of 3 years after the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.
